

Sub: Reduction of minimum admissibility of basic pay for availing Motor Car Advance.

In pursuance of the decision taken by the Government of Orissa through Finance Department Office Memorandum No. 16153/F dated 03.06.2015 and as per approval of the competent authority, the admissibility of basic pay for Motor Car Advance is revised from existing Rs. 18,600/- to Rs. 17,000/- (irrespective of grade pay). The revised rate of admissibility will come into effect from the date of issue of the order.

The rate of interest on the said advance is to be guided by Office order No. 15399 dated 27.08.2013, i.e. 12.5% per annum until further order.




